February 16, 2019

President Kerr called the meeting to order at 8:30 a.m. No Color Guardsman being present, the Colors were posted in advance of the meeting. COM JY Miller offered the invocation. The Pledge of Allegiance was led by COM Jim Lee; and, the SAR Pledge was led by COM Garrison Chance. President Kerr recognized the visitors that were present. There were 16 members and 10 guests and visitors in attendance. President Kerr also called for the recognition of birthdays and anniversaries. The health status of COM Jim Cunningham and his wife was acknowledged by COM DeVenney. President Kerr announced that it was good to see COM Coutts in better health and attendance.

President Kerr called upon COM JY Miller to conduct the 50/50 drawing. Upon the offer and sale of additional tickets, Mrs. Hank Hammons' number was drawn and was announced the winner of \$18. The remainder of the 50/50 ticket sales proceeds will be delivered to the Chapter Treasurer.

President Kerr recognized COM DeVenny who made a motion for the MGC Chapter to underwrite the annual chapter dues for four named chapter members who have made significant contributions of time and talent to the MGC Chapter. After discussion, the motion was withdrawn pending the development of specific criteria for the program by amending the bylaws, to authorize the chapter dues payment by a vote of the members. COM JY Miller offered to collect and present criteria ideas for consideration at a future chapter meeting.

The meeting was recessed for breakfast at 8:54 a.m.

President Kerr reconvened the meeting at 9:15 a.m. and then introduced the speaker for the meeting, Mr. Kirk Klingher, the site coordinator for the Missouri Veterans Project in Boonville, MO.

Mr. Klingher explained that the Missouri Veterans Project is a not-for-profit corporation organized to record the oral histories of Missouri's military veterans. Comprised of seven chapters around the state in cooperation of the University of Missouri System, the State Historical Society off Missouri and the Library of Congress corporate and other donors, the Project's goal is to obtain as many oral histories of veterans as possible.

A digital record of each video recorded interview is shared with the Library of Congress, the State Historical of Missouri as well as the veteran.

Following his presentation, Mr. Klingher was presented with a Certificate of Appreciation for his program.

President Kerr next asked that the usual reports be offered:

Recording Secretary Minutes: As there was no January meeting, due to the weather, President Kerr advised that the minutes for the December 2018 meeting had been distributed in advance. After discussion and upon hearing no call for amendments, COM Hillis made a motion to approve the minutes as presented. The motion was seconded by COM Charles Lee. The motion to approve the December 2018 minutes was unanimously adopted. Treasurer's Report: COM Stone offered the Treasurer's report. A copy of the report will be filed for audit.

Genealogy: COM Coutts offered the genealogy report. COM Coutts announced the approval of one new application, Darrel Hogue. The report also included 10 applications in various stages of completion and 2 member applications and 2 supplemental applications at National, pending approval.

Eagle Scout Committee: No report.

Project Patriot Tea: President Kerr advised the meeting attendees of the planned Project Patriot Tea, sponsored by the Columbian Chapter of the DAR, to benefit the Fisher House to be held on April 1st, 2019. Proposal for Chapter donation to the CAR State Project: President Kerr recognized COM DeVenney who announced that the State Project of the Missouri Society of the Children of the American Revolution is to "Raise funds to assist children in need of prosthetics"; and, suggested that the MGC Chapter consider a donation to support that CAR effort, led by his Grandaughter who is the society's current President.
