M. Graham Clark Chapter of the SAR - Minutes of Meeting 14 May 2022

The meeting was called to order by President David Bartlett at 8:36 a.m. at the Country Club of Missouri.

The colors were posted prior to the meeting. There was no color guard.

The Pledge of Allegiance was led by COM Samuel Thomas. COM Garland Lessley then offered the opening prayer. The Pledge to the SAR was led by COM Jim Lee.

President Bartlett recognized guests who included COM J. Y. Miller's wife, Mary, COM Dr. Luke Lucas' wife, Kathryn, COM Terril Jones' wife, Debbie and COM Mitchell Moore's wife, Sharon. A total of 20 members, spouses, and guests were in attendance.

Birthdays and anniversaries for the month of May included COM David Bartlett's wife, Priscilla, COM Bob Bartlett (97), COM Mitchell Moore's wife, Sharon. COM J. Y. Miller and his wife, Mary, celebrate their wedding anniversary in May.

Those recognized for sick call included COM Wayne Merrill's wife, Patricia and COM Garland Lessley.

At 8:41, President Bartlett announced a break for breakfast, served buffet-style and of prepandemic quality. President Bartlett reconvened the meeting at 9:05.

President Bartlett introduced the day's presenter, COM J. Y. Miller who gave a presentation entitled, "History of the M. Graham Clark Chapter, MOSSAR."

Montague Graham Clark was an education pioneer and president of the College of the Ozarks, near Branson, Missouri, from 1952-1975. He held five doctoral degrees and was an ordained minister.

Clark was also a flying enthusiast and the local airport in Branson, M. Graham Clark Field, was named for him; and it was a very busy airport prior to Branson's new airport being opened in 2009.

M. Graham Clark was President General of the Sons of the American Revolution in 1974. In the late 1970's he saw the need for an SAR chapter in central Missouri and in January of 1980 a steering committee was created to form a chapter, which was approved by September 1980. The members honored M. Graham Clark by naming the chapter for him. Clark personally attended the meeting in March, 1981 when the charter's first officers were elected.

COM Miller recounted the various meeting places for the Chapter during its first 20 years, the names of early officers and members, and encouraged members to go to the Chapter website to learn more. President Bartlett thanked COM Miller for his informative presentation.

COM Russell DeVenney reported on the **MOSSAR annual meeting** held in St. Louis April 29 and 30 which he and COM Wayne Merrill attended. Highlights of the meeting are attached, including awards and certificates received by the Chapter and its members. COM DeVenney and COM Merrill each received an award for Distinguished Service and COM Richard Moore earned a BSA Volunteer Medal from the National Society of Robert E. Burt for his work with the Boy Scouts.

Secretary Mitchell Moore announced the minutes of the last meeting were on the website and a copy at each table and asked if there were any revisions to be made. Hearing none, COM J. Y. Miller moved to accept the report, COM DeVenney seconded. Motion passed.

Treasurer COM DeVenney then gave the Treasurer's Report. A copy is attached. COM Mitchell Moore moved to accept the report. COM J. Y. Miller seconded. Motion passed.

Genealogist/Registrar COM John Coutts gave a Genealogy Report, which is attached. COM Mitchell Moore moved to accept the report. COM Charlie Lee seconded. Motion passed.

The 50-50 drawing was held COM J. Y. Miller with COM Samuel Thomas winning \$15.

President Bartlett reminded members that the next meeting of the M. Graham Clark Chapter of the SAR will be after the summer hiatus on September 17, 2022 at 8:30 a.m. at the Country Club of Missouri. At that meeting, Kevin Stull, in WWI uniform, will present on "Harry Truman and WWI."

Programs for meetings the remainder of the year on October 15, November 19, and December 22 have not been finalized and members willing to present a program are encouraged to volunteer. COM Charlie Lee, COM Wayne Merrill, and COM Russell DeVenney are working on a presentation to answer questions about the color guard and what is needed for anyone wishing to be a member of the color guard. Anyone desiring more immediate information can ask these compatriots questions, together with other members of the color guard, including COM John Coutts and COM Bruce Hillis.
