Notable dates – On Memorial Day, several members attended the wreath-laying ceremony at the Boone County Courthouse. President Hiles attended a historical display at Boonville. COM Russell DeVenney and his wife Laura attended the SAR National Convention. Constitution Day commemorating the signing of the U.S. Constitution on September 17, 1787. COM Charles Lee attended the ceremony at the Boone County Courthouse where the DAR had a program and the bell in front of the courthouse was rung. COM Wayne Merrill reported on activities of the Color Guard. COM John Coutts appeared with Color Guard members from Chapters around the state at the Missouri State Fair in August.
